In exercise of the powers conferred by proviso to Article 309 of the Constitution of India, the Governor of Madhya Pradesh hereby makes the following further amendments in the Madhya Pradesh Pensioner Welfare Fund Rules, 1997, namely :-

AMENDMENTS

In the said rules -

- (1) for rule 2, the following rule shall be substituted, namely :-
 - " 2. These rules shall apply to all pensioners of the State Government and the members of their families residing in the State of Madhya Pradesh."
- (2) for rule 4, the following rule shall be substituted, namely :-
 - " 4. Eligibility :- All Pensioners of the State Government and the members of their family, residing in the state of Madhya Pradesh shall be eligible to receive assistance from the said Fund upto the limit as prescribed under these rules, for the reasons enumerated in these rules."
- (3) after rule 4, the following rule shall be inserted, namely :-
 - " 4-A. The State Government shall contribute in the fund the amount at the rate of rupees five per year, per pensioner for all these pensioner who have retired from State Government service and who reside in the State of Madhya Pradesh and for this purpose the necessary budget provision shall be made every year under the Major Head 2054-Treasury and Accounts Administration-800 Other Expenditure-Relief from pensioner welfare Fund."
- (4) the second proviso to rule 5 shall be omitted.
- (5) for rule 6, the following rule shall be substituted, namely :-
 - " 6. Limit of assistance :- The maximum limit of assistance under rule 4-A shall be as under :-
 - (a) For treatment within the State :-
 - (i) Pensioners retired from class IV Posts, hundred percent of expenditure incurred, limited to maximum limit of Rs. 6,000/-per annum.
 - (ii) pensioners retired from class III posts, fifty percent of expenditure incurred, limited to maximum limit of Rs. 3,000/- per annum, and
 - (iii) Pensioners retired from class II and I posts, twenty five percent of expenditure incurred limited to maximum limit of Rs.1,500/- per annum
 - (b). For treatment out-side the State :-
 - (i) Pensioners ratiored from class IV posts, hundred percent of expenditure incurred, limited to maximum limit of Rs. 20,000/-per annum.

- (ii) Pensioners retired from Class III posts, fifty percent of expenditure incurred, limited to maximum limit of Rs. 10,000/- per annum, and
 - (iii) Pensioners retired from Class II and I posts, twenty five percent of expenditure incurred, limited to maximum limit of Rs, 5,000/- per annum.
- (5) These amendments shall come into force with effect from the date of their publication in the Madhya Pradesh Gazette.
